

Strathmoor Manor - Garbage & Upcoming Events (IMPORTANT)

Garbage Provider Change –

- The city is changing waste providers. The final WM pickup will be on Tuesday 6/25/24. After Waste Management’s final pickup they will collect totes, leave all totes out and empty until they are retrieved by Waste Management on or after Tuesday June 25, 2024.
- Ecotech will begin waste, recycling, and yard collection services on July 2, 2024. They will deliver 1 recycling and 1 garbage tote between 6/24 and 6/25. A welcome letter is on the back of this communication.

Upcoming Events/Other –

- **Elections** – Your commissioner’s terms are ending. The city must have commissioners to continue or could be annexed by another city. ***Calling interested residents to step up and run for office!***
 - Here is how you run:

 - This is the write-in form and you have through at least September to be an official candidate/submit the form. The period to have a candidate’s name appear on a ballot passed in early June.

- 4th of July Parade – This tradition will continue with popsicles and the Fire Truck. Meet at the Park at 10:00 AM.
- Taxes – Property Taxes in FY 24 will go down from \$0.30 / \$100 in assessed value to \$0.25 / \$100 in assessed value. Strathmoor Manor provides numerous services beyond the scope provided to our Louisville Metro neighbors at a lower cost. See chart below:

 Strathmoor Manor taxes, due to property revaluations, will go down from 30 basis points to 25 basis points in FY 24. Strathmoor Manor pays \$94 less per \$100,000 in assessed property value than a Louisville Metro neighbor.

CITY OF STRATHMOOR MANOR
 Ordinance Series 2024, Number 1

AN ORDINANCE relating to the ad valorem tax rate on real property.

BE IT ORDAINED BY THE CITY OF STRATHMOOR MANOR that:

Section 1. Section 2.605(a) of the Strathmoor Manor Code of Ordinances shall be amended to read as follows:


The tax rate on non-exempt real property within the corporate limits of the City of Strathmoor Manor shall be 25.0 cents per \$100.00 valuation.

Section 2. Section 2.605(b) of the Strathmoor Manor Code of Ordinances is amended to read as follows:


This ordinance shall take effect with the issuance of the 2023-2024 Property Tax Bills of the City based on valuations of real property as of January 1st, 2023-2024 by the Jefferson County Property Valuation Administrator.

Section 3. This Ordinance shall take effect upon enactment and publication.

Our carts (1 trash & 1 recycle) will be delivered between 6/24-6/25. Additional carts upon request rent for 4.50/mo. & billed annually. Please have your trash, recycling, and yard waste at the curb the night before or no later than 6:00 a.m. the day of service. (Please see reverse side of letter regarding proper placement of carts)

2024 HOLIDAY SCHEDULE

Independence Day - Tuesday, July 4th, 2024. We will be running on a 1 day delay from Tuesday through Friday.

Labor Day - Monday, September 2nd, 2024. We will be running on a 1 day delay the entire week.

Thanksgiving Day - Thursday, November 28th, 2023. We will be running on a 1 day delay Thursday & Friday.

Christmas Day - Wednesday, December 25th, 2024. We will be running on a 1 day delay the entire week.

To provide safe and efficient service, we ask that you please sit your containers curbside on one side of the driveway, clear of any obstructions. All trash must be properly bagged and placed inside the trash container. All recycling must be placed inside the recycle cart with the yellow lid.
